- 2) Please provide the total number of people detained for immigration-related reasons during the years 2010, 2011, and 2012.
- 3) Please provide the total number of asylum seekers who were placed in detention during the years 2010, 2011, and 2012.ⁱⁱⁱ

Response to Request for information on immigration Related Detention from Graduate Institute.

- 1. As far as Prison and Probation Services fields of responsibility, there are two locations, where non-citizens can be held of immigration-related reasons. It consists of a local prison, Aabenraa Arrest and Ellebæk Institution. The two institutions had a capacity in 2012 on a daily average basis of 123 places for asylumseekers. Besides that people can be detained in Remand Prison according to the Act of Alien.
- 2. The total number of people detained in Remand prisons according to the Alien Act (immigrationlaw?) makes a total of :

2012: 127

2011: 82

2010: 63.

3. 86 asylum seekers were placed in Aabenraa Arrest and Ellebæk Institution on a daily average basis in 2012. In 2011 it was 65 and in 2010 it was 53.

Outside the Prison and Probation Services fields of responsibility asylum seekers are placed in Red Cross Asylumcenters.
